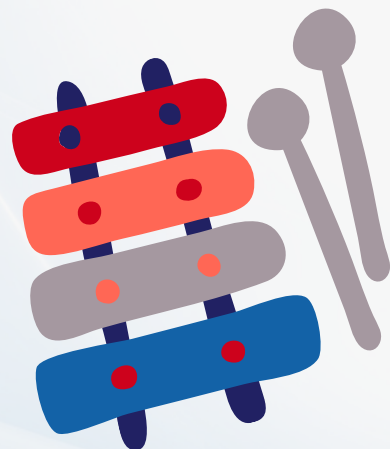

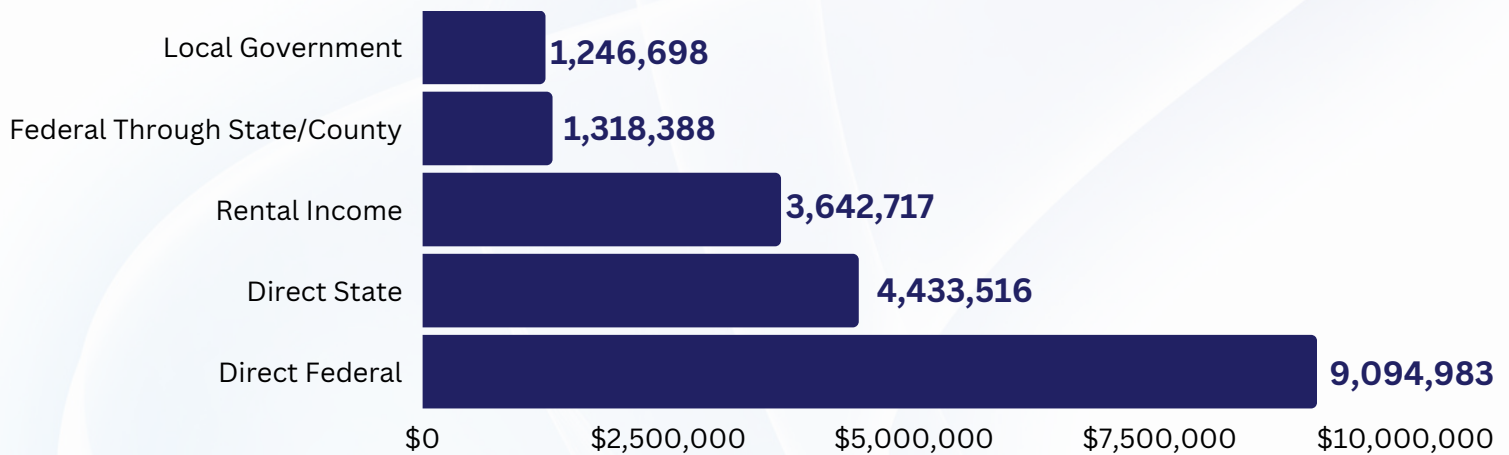


FINANCIAL INFORMATION

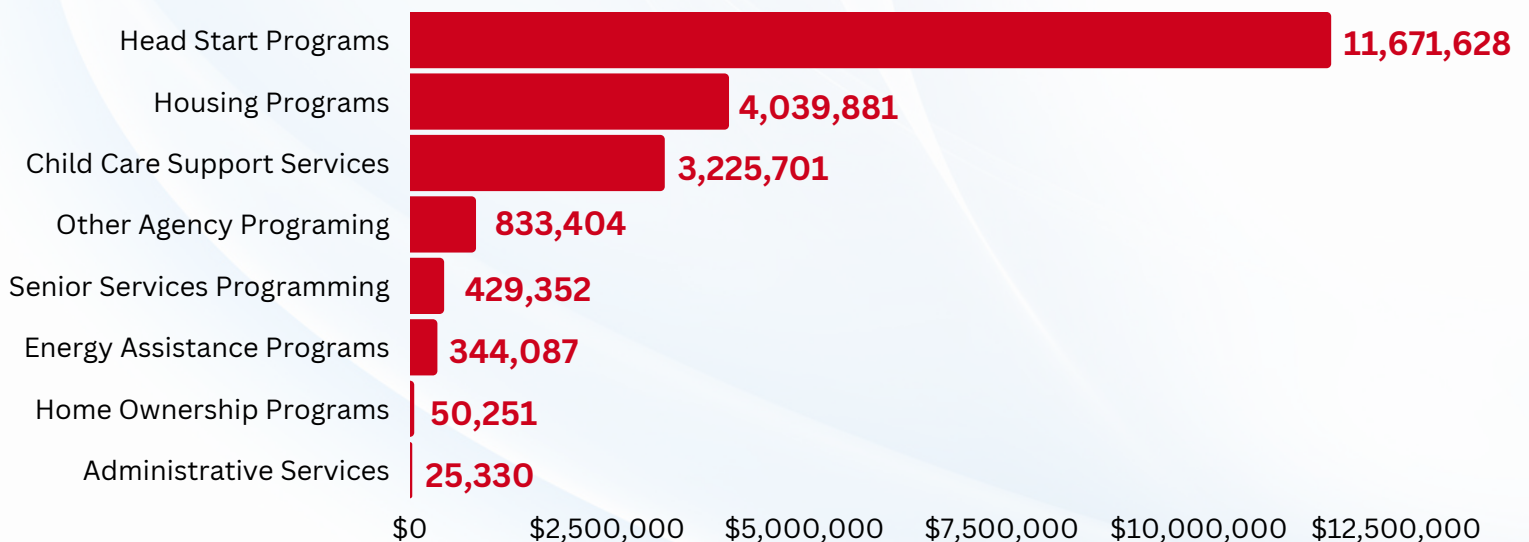
The results of the most recent 2021 FISCAL AUDIT found no material findings. The most recent Federal Monitoring Review took place in June 2021 there were no findings or areas of non-compliance.

It is the policy of the Governing Board of the Anoka County Community Action Program to administer its funding on the basis of accounting practices prescribed by the various funding sources. These policies conform to Generally Accepted Accounting Practices (GAAP). Independent auditors, who are Certified Public Accountants, have examined ACCAP's financial statements and have found ACCAP to operate in compliance with funding source requirements and GAAP. The following summary of the Agency's sources and uses of funds were prepared from figures included in the most recent audited financial statements for the fiscal year ending December 31, 2022.
